The contact details shall not be revealed to any external party until the selection process is completed.
- The selected slogan will further be used to promote mSeva AppStore awareness.
- The slogan can be submitted in either English or Hindi.
- The slogan should be typed, and font size should not be less than 12.
- Participants can take part in the contest by registering on MyGov (www.mygov.in)
- Copyrights will solely be with C-DAC Mumbai once submitted for the competition.
- The entry must not contain any provocative, objectionable, or inappropriate content.
- The winners must share their consent to the use of their names in any publicity carried out by C-DAC Mumbai without further compensation.
- There will be no notification to participants of entries not selected as winners.
- All entries will be judged on the basis of creativity, originality, and composition by the C-DAC Mumbai
