## **Poster-Making Competition on '6 Years of UMANG**

### **Terms and Conditions**

1. The competition is open to individuals only.
2. Poster can be submitted in a PDF or JPEG image file only. The participants may hand draw/sketch the poster on A3 or A4 pages or create a digital poster through design software.
3. All submissions must be original and not infringe upon any existing copyrights or trademarks.
4. Entry into the contest is open to all entrants, who are residents of India or of Indian origin. Though employees of NeGD/ MeitY/ MyGov/ SeMT and UMANG's partner organizations, past or present, and their immediate family members may participate they shall not be considered in the list of winners.
5. Organizers shall not be responsible for entries that are lost, late, incomplete, or could not be submitted due to any issue/error, technical or otherwise, which is beyond the organizer's reasonable control. Please note that the 'proof of submission' of the entry is not the 'proof of receipt' of the same.
6. If a winner is not reachable within five working days from the announcement of the results, the corresponding prize shall be deemed to have been forgone and another winner shall be selected from the remaining eligible entries, in accordance with the above process, until the winner is contactable.
7. Organizers reserve the right to disqualify and/or refuse/restrict the participation of anyone, if, in their reasonable assessment, such participation and/or association of any participant is detrimental to the contest and/or organizers and/or partners of the contest.
8. MeitY will reserve the right to use the submitted material in external communication and knowledge products giving due credit to the creator. Participants may be required to furnish proof of identity if requested.
9. By participating in the competition, winners agree to use their name and submissions for publicity and promotional purposes related to the competition. Further, each participant will be required to provide their name, email address, telephone number and postal address for submitting their entry.
10. One participant can submit a maximum of one entry only. Once submitted an entry cannot be withdrawn.
11. Registration shall be void if the information received by the organizers is illegible, incomplete, damaged, false or erroneous.
12. In the event of unforeseen circumstances, organizers reserve the right to amend or withdraw the contest at any time, including the terms and conditions.

13. Organizer's decision on the result of the competition shall be final and binding and no correspondence shall be entertained regarding the same.
14. By entering the competition, the participant accepts and agrees to the Terms and Conditions, as mentioned above.
15. The content must be original and should not violate any provision of the Indian Copyright Act, 1957. Anyone found infringing on others' copyright would be disqualified from the competition. The government of India does not bear any responsibility for copyright violations or infringements of intellectual property carried out by the participants.
16. MyGov reserves the right to cancel or amend all or any part of the Contest and/ or the Terms & Conditions/ Technical Parameters/ Evaluation Criteria. However, any changes to the Terms & Conditions/ Technical Parameters/ Evaluation Criteria, or cancellation of the Contest will be updated/ posted on the MyGov platform.
