## Tagline Writing Competition for 6 Years of UMANG

### Terms and Conditions

1. The competition is open to individuals only.
2. Submissions only allowed through a MS Word document or PDF file.
3. Taglines should be concise and limited to a maximum of 7 words. The tagline should be either in Hindi or English language only.
4. Entry into the contest is open to all entrants, who are residents of India or of Indian origin. Though employees of NeGD/ MeitY/ MyGov/ SeMT and UMANG's partner organisations, past or present, and their immediate family members may participate but they shall not be considered in the list of winners.
5. All submissions must be original and not infringe upon any existing copyrights or trademarks.
6. Organisers shall not be responsible for entries that are lost, late, incomplete, or could not be submitted due to any issue/error, technical or otherwise, which are beyond the organizer's reasonable control. Please note that 'proof of submission' of the entry is not the 'proof of receipt' of the same.
7. If a winner is not reachable within five working days from announcement of the results, the corresponding prize shall be deemed to have been forgone and another winner shall be selected from the remaining eligible entries, in accordance with the above process, until the winner is contactable.
8. Organisers reserve the right to disqualify and/or refuse/restrict participation of anyone, if, in their reasonable assessment, such participation and/or association of any participant is detrimental to the contest and/or organisers and/or partners of the contest.
9. MeitY will reserve the right to use the submitted material in external communication and knowledge products giving due credit to the creator. Participants may be required to furnish proof of identity, if requested.
10. By participating in the competition, winners agree to use their name and submissions for publicity and promotional purposes related to the competition. Further, each participant will be required to provide their name, email address, telephone number and postal address for submitting their entry.

11. One participant can submit a maximum of one entry only. Once submitted an entry cannot be withdrawn.
12. Registration shall be void if the information received by the organisers is illegible, incomplete, damaged, false or erroneous.
13. In the event of unforeseen circumstances, organisers reserve the right to amend or withdraw the contest at any time, including the terms and conditions.
14. Organiser's decision on the result of the competition shall be final and binding and no correspondence shall be entertained regarding the same.
15. By entering the competition, participant accepts and agrees to the Terms and Conditions, as mentioned above.
16. The content must be original and should not violate any provision of the Indian Copyright Act, 1957. Anyone found infringing on others' copyright would be disqualified from the competition. The government of India does not bear any responsibility for copyright violations or infringements of intellectual property carried out by the participants.
17. MyGov reserves the right to cancel or amend all or any part of the Contest and/ or the Terms & Conditions/ Technical Parameters/ Evaluation Criteria. However, any changes to the Terms & Conditions/ Technical Parameters/ Evaluation Criteria, or cancellation of the Contest will be updated/ posted on the MyGov platform.
