- 4. Contestants can make multiple entries.
- 5. Submissions will be accepted only through MyGov Portal. No direct entries to Ministry of Ayush (MoA) will be accepted.
- 6. No submission will be accepted after the last date of submission.
- 7. Entries by you should not violate the privacy rights, publicity rights, copyright or other intellectual property rights of any person or entity.
- 8. A contestant may not reproduce in any the way any copyrighted material, trademarks or other proprietary information without obtaining the prior written consent of the owner of such proprietary rights.
- 9. Contestants agree to unconditionally indemnify and hold MoA, subsidiaries, affiliates, officers, agents, representatives and employees harmless from any loss, liability, claim, or demand, including attorneys' fees, relating to any claim made by any third party due to or arising out of your violation of any of the foregoing terms and conditions and/or any breach of your covenants, representations and warranties set forth above.
- 10. Without limiting our rights, MoA will terminate all relations with any contestant who infringes copyright upon our receipt of a notice of infringement from the copyright owner or the copyright owner's legal counsel
- 11. Award winning submission will be property of MoA. MoA shall be free to publicize the winning concepts in the way deemed fit by the organisation.
- 12. None of the participants including contest winners shall be reimbursed any charge for any aspect of conceptualisation, writing, composing or production of the jingle.
- 13. Once, MoA has awarded the selected participant or contestant, MoA shall not attribute the product name to the participants in any of its advertisements etc.
- 14. Submissions which do not meet with the submission guidelines shall be disqualified.
- 15. MoA is not liable to give any explanation whatsoever for short listing or rejecting any entry.
- 16. MoA reserves the right to change competition deadlines and dates due to circumstances beyond its reasonable control.
- 17. MoA reserves the right to use any of the submissions, irrespective of the fact that they are award winning submission or not, in any manner deemed suitable by MoA.
