- 4. Sensitize the students of senior classes about the ill-effects of corruption in the society and promote moral values amongst the students.
- 5. Sensitize the staff members for creating awareness about the ill-effects of corruption and to promote probity, integrity and honesty. Special emphasis may be given to encourage the youth in various activities emphasising the importance of integrity and ethics.
- 6. Organize various activities such as lectures, panel discussions, debates, quiz, essay writing, slogans/ elocution/ cartoon/ poster making competitions on moral values, ethics, good governance practices etc. covering the theme of Vigilance Awareness Week so as to generate healthy debate on corruption and for ensuring active participation of students.
- 7. Organize seminar/ workshop in the school on the theme of Vigilance Awareness Week.
